**RIDER SCHEDULE PPR-1****APPLICATION**

Applicable to pipeline pumping station customers (Standard Industrial Classification codes 4612 and 4613).

**BILLING**

In accordance with the provisions of the ALGS Rate Schedule, except that the Customer's Demand shall be defined as the average kW supplied during the fifteen-minute period of Customer's greatest use during the current month's On Peak Hours, but not less than the greater of:

- (1) 80% of the highest On-Peak Hours kW so established during the Summer Months of the prior eleven months, or
- (2) 40% of the highest Off-Peak Hours kW so established during the Summer Months of the prior eleven months, or
- (3) 40% of the highest kW so established during the non-Summer Months of the prior eleven months, or
- (4) the minimum kW specified in the Agreement for Service, or
- (5) 5000 kW.

**Summer Months**

The calendar months May through September.

**On-Peak Hours**

1:00 PM until 8:00 PM local time, Monday through Friday during the Summer Months. Upon a minimum of thirty minutes notification to Customer, Company may expand the On-Peak Hours, but such expansion shall not exceed the hours of 11:00 AM through 9:00 PM local time, Monday through Friday, during the Summer Months. The Company will provide the Customer with written notification of the duration period for the expanded On-Peak Hours, when such expansion period exceeds more than five consecutive days.

7:00 AM until 9:00 PM local time, Monday through Friday during the non-Summer Months.

**Off-Peak Hours**

All other hours not defined as On-Peak Hours and all hours during New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day.

If the instantaneous load exceeds the highest average fifteen-minute load by an unusual amount, such instantaneous load may be taken as the demand used for billing.

**CONTRACT PERIOD**

The Contract Period shall be for an initial term of five (5) years with one (1) year extensions thereafter.

**RESERVATION**

Subject to orders of regulatory authorities having jurisdiction and to the provisions of Company's Service Policy on file with the Mississippi Public Service Commission
