**RIDER SCHEDULE BB-2 (Revised)****APPLICATION**

Upon request by the customer and concurrence by the Company, this rider will be applied to residential customers, churches and synagogues billed under the applicable rate schedule(s), and commercial and industrial customers billed under the General Lighting and Power Rate Schedule. All customers must have a credit standing satisfactory to the Company to be eligible for billing under this Rider Schedule BB-2 (Revised). The purpose of this Rider Schedule BB-2 (Revised) is to provide the customer with two options for equalizing, to the extent practicable, the monthly amounts to be paid by the customer during the year.

Not applicable for temporary, seasonal, standby or supplementary service or with time of use rate schedules.

All provisions of Company's applicable rate schedule apply except as modified herein.

**BILLING OPTIONS****LEVELIZED BILLING**

The customer's monthly use will be billed at the applicable rate schedule(s), and the customer's account debited in the usual manner. The amount so determined will be adjusted so that the net amount payable for service in the current month shall equal, to the nearest whole dollar, the average monthly amount billed to the customer under the applicable rate for the twelve (12) months ending with the current month, plus or minus one-twelfth (1/12) of the accumulated difference between the previous monthly amounts debited and the net amounts payable for monthly service under this option.

**EQUAL PAY**

The customer's monthly bill will be computed in accordance with the applicable rate schedule(s), and the account debited in the usual manner. In the first twelve (12) months the amount so determined ("Billed Amount") will be adjusted so that the net amount payable for service in the current month ("Equal Pay Amount") shall equal, to the nearest whole dollar, one-twelfth (1/12) of the current plus eleven (11) previous months' amounts billed for all metered electric service(s) to the account. During the billing process of the thirteenth (13<sup>th</sup>) month, and during the billing process of each subsequent thirteenth (13<sup>th</sup>) month, the Equal Pay Amount will be recalculated. The new Equal Pay Amount for the current and next eleven (11) months will equal one-twelfth (1/12) of the sum of the current and prior 11 months' Billed Amounts plus the current balance of the accumulated differences between the previous twelve (12) months' Billed Amounts and Equal Pay Amounts.

The Equal Pay Amount may be adjusted in any month in which there is significant variation between the Equal Pay Amount and the accumulated difference between the Billed Amounts and the Equal Pay Amounts.

**TERMINATION AND SETTLEMENT**

Billing under this Rider Schedule BB-2 (Revised) shall be subject to termination by either party upon appropriate notification to the other and shall be automatically terminated upon discontinuance of service for any reason.

Should the customer request that billing under this Rider Schedule BB-2 (Revised) be terminated, said customer shall not be eligible for billing under this Rider Schedule BB-2 (Revised) until the seventh (7<sup>th</sup>) billing month following such termination.

In the event billing under this Rider Schedule BB-2 (Revised) is terminated, the balance in the customer's account shall become due and payable.

Nothing in this rider shall be construed to waive the Company's rights, as stated in its Service Policy and the Commission's rules, to discontinue service in event of failure to pay bills, or for any other lawful cause as set forth in said Service Policy and rules.
