**IRRIGATION PUMPING POWER RATE SCHEDULE IPS-26**

---

**I. AVAILABILITY**

At points on existing facilities having adequate capacity and suitable voltage for delivery of service from the Company's interconnected transmission system.

**II. APPLICATION**

For electric service to farm irrigation systems supplied at one point of delivery and measured by one kilowatt-hour meter.

Service is for the exclusive use of the customer and shall not be resold or shared with others. Not applicable to standby or supplementary service.

**III. CHARACTER OF SERVICE**

Three phase, 60 cycles, and at one standard nominal voltage as required by Customer, as described in Company's Standards For Electrical Installations. Company furnishes transformation equipment for one utilization voltage only.

**IV. NET ON-SEASON RATE****A. RATE**

For the first 540 hours use of Customer's Seasonal Load per Season

\$ 0.176552 per kWh for the first 4,000 kWh  
\$ 0.147768 per kWh for the next 20,000 kWh  
\$ 0.133693 per kWh for additional kWh

For the excess above 540 hours use of Customer's Seasonal Load per Season

\$ 0.070276 per kWh

**B. MINIMUM BILL**

\$12.89 per Season for each kW of Customer's Seasonal Load but not less than \$129.00

**V. NET MONTHLY OFF-SEASON RATE**

\$ 3.82 per kW of Customer's Off-Season Load which entitles Customer to use 50 kWh per kW of Customer's Off-Season Load  
\$ 0.090519 per kWh for all additional kWh

**VI. ADJUSTMENTS**

Bills rendered under the foregoing Seasonal Rate or Net Monthly Off-Season Rate shall be subject to the following adjustments:

First - Plus or minus an amount determined in accordance with Company's effective Energy Cost Recovery Rider on file with the Mississippi Public Service Commission.

Second - Plus or minus a percentage adjustment on the pre-tax billing sufficient to compensate Company for any increase in income taxes above the 1993 level or to reduce Customer's billing to adjust for any decrease in any effective income tax rates.

Upon any change in the effective rates of income taxes the Company will file within 30 days the percentage adjustment to be applied for the remainder of the year based on operations for the prior calendar year. Subsequently the percentage adjustment to be applied during a year will be filed with the Commission prior to February 1 of each year and will be based on the prior calendar year's operations. The adjustment will be such percentage as may be necessary to obtain the same after-tax income under the effective tax rates as would have been realized under the income tax rates in effect for the year 1993 without this income tax adjustment.

Third - Plus the applicable proportionate part of any directly allocable tax, impost, or assessment imposed or levied by any governmental authority, which is assessed or levied against the Company or directly affects the Company's cost of operation and which the Company is legally obligated to pay on the basis of meters, customers, or rates of, or revenue from electric power and energy or service sold, or on the volume of the energy generated, transported, purchased for sale, or sold, or on any other basis where direct allocation is possible.

**VII. ON-SEASON**

Five months beginning with the first regular meter reading date after each May 15, unless otherwise agreed upon. Billing will be continuous during the Season.

**VIII. OFF-SEASON**

All months not included in the On-Season. There will be no proration of bills for periods of less than one month.

**IX. CUSTOMER'S SEASONAL LOAD**

The average kW supplied during the fifteen-minute period of Customer's greatest use during the twelve months ending with the current month but not less than the greater of 75% of the maximum kW specified in the Agreement For Service, or 5 kW.

**X. CUSTOMER'S OFF-SEASON LOAD**

The average kW supplied during the fifteen-minute period of Customer's greatest use during the current month but not less than 5 kW.

**XI. BILLING**

The On-Season minimum will be billed on the first bill rendered at the beginning of the season and will be based on the Seasonal Load as of the reading date. If any higher Seasonal Load is subsequently established during the Season, additional minimum charges will be billed if due. Any amount billed as minimum in excess of energy charges in any month of the Season will be credited against energy used by the customer in a subsequent month of the same Season, if there be one.

**XII. CONTRACT PERIOD**

- (1) Not less than two years when new or additional facilities are involved and extended for one-year periods thereafter, or
- (2) not less than one year at existing locations where no new or additional facilities are involved and when required by the currently effective Character of Service Available.

**XIII. RESERVATION**

Subject to orders of regulatory authorities having jurisdiction and to the provisions of Company's Service Policy currently on file with the Mississippi Public Service Commission.
