Code Ann. Sec. 77-3-35(1) that do not specifically and explicitly incorporate this Rider into the contract.

(2) Pursuant to Section V of Entergy Mississippi's Storm Damage Rate Schedule SD-9 (Revised), all SD rate adjustments will be zero beginning with the second billing month following the month that the balance in Storm Damage Reserve exceeds \$15.0 million, and the Schedule SD-9 (Revised) Rate Adjustments shall remain at zero until the second billing month following the month that the balance in the Storm Damage Reserve becomes less than \$10.0 million, from and after which time the Schedule SD-9 (Revised) Rate Adjustments billed under this Schedule shall again be the same as set out hereinabove.

(3) The above Rate Adjustments will be added to the Net Monthly Rates or Net Seasonal Rates set forth in Entergy Mississippi, LLC's currently effective rate schedules identified above, or such superseding rate schedules as may be ordered by the Commission, or such other rate schedules of Entergy Mississippi, LLC subject to the Rider SD-9 (Second Revised) that may become effective, whether or not such schedules supersede any of the rate schedules above, but not including special contracts entered into pursuant to Miss. Code Ann. Sec. 77-3-35(1) that do not specifically and explicitly incorporate this Rider into the contract.
