STANDBY OR SUPPLEMENTARY SERVICE RIDER SCHEDULE SS-12

I. AVAILABILITY

At points on existing facilities having adequate capacity and suitable voltage for delivery of service from the Company's interconnected system.

II. APPLICATION

This Rider is applicable in conjunction with Company's standard rate schedule for General Lighting and Power, Intermediate General Service, Large General Service, High Load Factor General Service and Alternate Large General Service where Customer's electric energy requirements are partially or entirely supplied by Customer's generating facilities; not applicable where Customer's generating facilities are used exclusively for emergency service in case of failure of normal supply from Company.

Where the Company-owned source of power is connected either electrically or mechanically to equipment which may be concurrently operated by service supplied by Company, there shall be installed and maintained at Customer's expense, protective devices as specified or approved by Company.

III. BILLING

Power and energy delivered to the Customer shall be billed in accordance with the terms of the schedule to which this Rider is attached, subject to the provisions of this Rider, plus the monthly standby charge provided hereunder.

Increases in Customer Demand or Measured Load caused by outages on Customer's generating facilities shall be waived in the determination of Customer's billing during subsequent billing periods. In the event of an outage of Customer's largest generating unit, the Standby Charge for the billing period shall be waived to the extent of the increase in charges to the customer under the attached rate schedule due to such increase in Customer Demand or Measured Load. If Customer has two or more generating units of equal capacity which are Customer's largest generating units, the Standby Charge divided by the number of such units shall be waived to the extent of such increase in the charges to the Customer. It shall be the customer's responsibility to notify the Company in writing within five days following the onset of such an outage.

IV. MONTHLY STANDBY CHARGE

\$6.11 per kW of Standby Capacity

V. MINIMUM MONTHLY BILL

The amount computed in conjunction with the Monthly Standby Charge plus the amount computed under the applicable service schedule to which this Rider is attached.

VI. STANDBY CAPACITY

When Customer's potential maximum demand without respect to source of power is in excess of Customer's Total Capability (TC), Standby Capacity shall be determined as follows:

- kW = $.30(C) + .05(TC)$ where:
- kW = Kilowatts of Standby Capacity
- C = Capability of Customer's largest generating unit (where Customer has two or more generating units of equal capacity which are Customer's largest generating units, C equals the capability of one of them)
- TC = Total Capability of Customer's generating unit(s)

When Customer's potential maximum demand without respect to source of power is less than Customer's Total Capability (TC), Standby Capacity shall be determined as follows:

- kW = $.35(CL)$ where:
- kW = Kilowatts of Standby Capacity
- CL = Customer's Load without respect to source of power

For the purposes hereof:

- C = _____ kW
- TC = _____ kW

CL shall be the greater of _____ kW or the average kW supplied by the Company during the fifteen-minute period of greatest use subsequent to the date of commencement of service to the customer under this Rider Schedule.

VII. FACILITIES PROVIDED BY CUSTOMER

Customer shall provide all protective devices and other equipment necessary for the protection of his and the Company's personnel and equipment while receiving service under this Rider.

Customer shall reimburse Company for all additional metering equipment provided by Company for service provided under this Rider Schedule.

VIII. CONTRACT PERIOD

Not less than five years.

IX. RESERVATION

Subject to orders of regulatory authorities having jurisdiction and to the provisions of Company's Service Policy currently on file with the Mississippi Public Service Commission.
